**Course Description: Fire Inspector 2A** - This course provides students with a basic knowledge of the administrative requirements related to the roles and responsibilities of a Fire Inspector 2 including processing permit and plan review applications, enforcing permit regulations, investigating complex complaints, recommending modifications to codes and standards, recommending policies and procedures for inspection services, generating written appeals correspondence, initiating legal action, evaluating inspection reports, and proposing technical reference material acquisition.

- Fire Inspection and Code Enforcement (IFSTA, 8th edition, ISBN: 9780879396053)
